Includes all features of the standard license plus access to automated transfer of information to the DTC for transactions and cost basis (via CBRS); unlimited use of the Import Wizard; cross company reporting; customizable Cover Sheets; screen messages for each company.

### Account Ability – 1099 and other tax reporting and filing package

*No special forms needed! Prints 1099-B, 1099-DIV, 1099-INT and many more forms on plain paper and generates IRS FIRE filing.*

### Unlimited use of the Transfer and New Issue Import Wizard

*This option is included with the Advanced license or can be purchased as an add-on for the Standard license.*

\$300 initial license fee + \$400 annual license renewal and software support fee. Enables import of new shareholders and number of shares from Excel or other file formations during New Issues and Transfers.

With this module you can avoid manual data entry if, for instance, your company has a payroll stock purchase plan and the payroll department provides a spreadsheet of employees who are purchasing shares.

### Fractional Shares Module

This module enables entry of fractional shares to four decimals. (StockTrack™ default is full share.) \$500 annual license renewal and software support.

### Stock Pledge Module

Track shares held as collateral for loans.
